LAST WILL AND TESTAMENT

I, **Peter Foo (NRIC No. 000000-00-0000)** of Lot 10 Taman Murni, 16250 Wakaf Bharu, Kelantan, do hereby revoke all former wills and testamentary dispositions made by me and declare this to be my Last Will and Testament.

1. I appoint Michael Ng (NRIC No. 000000-00-0000) to be the sole Executor and Trustee of this, my Will.
2. If Michael Ng predeceases me or is unable or unwilling to fulfil this role, then I appoint Sarah Wong (NRIC No. 000000-00-0000) to be the Executor and Trustee of this Will.
3. My Executor and Trustee is to apply my assets towards the payment of my funeral and testamentary expenses, debts and all duties payable on or by reason of my death in respect of my estate.
4. If my spouse predeceases me, I appoint Natasha Goh (NRIC No. 000000-00-0000) as Guardian to my children.
5. I give all my properties and assets whatsoever and wheresoever situated, both moveable and immovable (including without limitation, cash), if they have not been sold or disposed off in my lifetime, to Jacleen Lee (NRIC No. 000000-00-0000) as the beneficiary of my Will.
6. If Jacleen Lee shall predecease me, then my entire estate (including all movable and immovable properties) whatsoever and wheresoever situated, shall be given to Ken Foo (NRIC No. 000000-00-0000) and Isaac Foo (NRIC No. 000000-00-0000) in equal shares. In the event any of these beneficiary(ies) shall predecease me, the entitlement that such predeceased beneficiary(ies) would have received shall instead be given to the surviving beneficiary(ies) in equal shares.

7. If all of the beneficiaries I have named in this my Last Will and Testament do not survive me or we shall pass away simultaneously, then my entire estate shall be given to the Society For the Prevention of Cruelty to Animals (SPCA Selangor) absolutely.

8. Solely for the convenience and ease of reference of my executor and trustee, I annex hereto as a general guide a schedule of some of the assets and properties which I currently hold. The said schedule shall not in any way prejudice the terms of this, my last Will and Testament and is not necessarily exhaustive or indicative of all my assets and properties, moveable or immovable and whatsoever and wheresoever situated whether as of the date hereof or as of the date this, my last Will and Testament takes effect.
